### TERMS AND CONDITIONS

#### GENERAL SAFETY

- Everyone wants to have a fun, safe Experience. Please follow all safety instructions of AdventureORX personnel and other event rescue personnel.
- If you feel uncomfortable or believe that you cannot safely execute any Experience activity, please let an AdventureORX staff member know. We are here to assist.
- AdventureORX reserves the right, in AdventureORX's sole discretion, to remove from the Experience anyone that we determine to pose a threat to the health or safety of any participant or attendee of the Experience.
- All drivers and passengers are required to sign a waiver before participating in the Experience.

#### SAFE DRIVING

- If you have questions about driving off-road let us know. We are here to help you have fun and learn to drive safely.
- If our AdventureORX personnel determines that your driving poses a threat to the safety of yourself or others, AdventureORX personnel reserves the right to terminate your experience.
- Please note, alcohol is prohibited onsite. You may not participate as a driver if you are impaired by or have any alcohol or performance-impairing drugs in your possession at any time during the Experience. If violations occur, AdventureORX personnel reserves the right to terminate your experience.
- All drivers must be at least 16 years old and hold a valid driver's license.
- No children under the age of 10 may ride in vehicles off-road during the Experience, unless AdventureORX permits them to do so in AdventureORX's sole discretion. Drivers and adult passengers are solely responsible for supervising all children in the vehicle and ensuring they are properly restrained at all times.

#### YOUR VEHICLE

- You are responsible for providing your own Model Year 2021 or later Ford Bronco vehicle for use during the Experience. You are also responsible for providing all necessary fuel and other operating costs for the vehicle.
- You are responsible for ensuring that your vehicle is in a safe operating condition and for determining the effects and potential safety impact of third-party modifications and after-market accessories.
- Your vehicle must be properly registered and insured under state law. If you do not own the vehicle, you must have permission to use the vehicle at the Event. You should bring verifying documentation to the Event.

#### ILLNESS PROTOCOL

- If you have a fever, please do not come to the Event. Call (855) 545-8593 and advise AdventureORX staff that you have a fever and cannot attend.
- It is imperative for you (and your guests) to self-monitor for the following symptoms:
  - Fever or chills
  - Cough
  - Fatigue
  - Muscle or body aches
  - Headache
  - New loss of taste or smell
  - Sore throat
  - Congestion or runny nose

- Nausea or vomiting
- Diarrhea
- Call (855) 545-8593 to reschedule should you be experiencing any of the symptoms listed above at the time of your event.

#### **COVID-19 PROTOCOL**

- If you have a known exposure to COVID-19 you should test yourself after five days of exposure and monitor your symptoms. If you become symptomatic at any point, please do not come to the event. Please call (855) 545-8593 and we will assist you in rescheduling your Event.
- If you have contracted COVID-19, you should not come to the event until 5 days have passed and you are fever free without fever reducing medications. You may come after five days of symptoms but will need to wear a mask for the remaining five calendar days.

#### **ADVENTURE ORX WELLNESS PROTOCOL**

- We are adhering to all local and state guidelines.
- We ask that you please comply with all applicable public health orders.
- AdventureORX is not responsible for transmission of COVID-19 or any other infectious disease during the Event.

#### **FEES**

- The fee to attend Bronco Off-Road Connect is \$550+tax for a 6-hour experience. This includes adding up to four (4) guests.
- Please note that all Bronco Off-Road Connect participants will be responsible for lodging and travel to and from the experience.

#### **CANCELLATION POLICY**

- 24 hours or more before your experience – receive a full refund minus a \$50 processing charge
- Less than 24 hours before your experience – no refund

#### **RESCHEDULING POLICY**

- You may reschedule your experience at any time for no fee subject to availability

#### **GUEST CHANGES**

#### **WEATHER AND UNANTICIPATED EXPERIENCES**

- In the experience of severe or inclement weather, AdventureORX may determine that it is in the best interest of safety to either delay or suspend an Experience.
- AdventureORX personnel have the authority to mitigate on-course risks, including those related to lightning and high winds. All participants must comply with the directions of AdventureORX personnel that are intended to mitigate identified course hazards.
- AdventureORX is not liable for any failure which occurs as a result or consequence of any cause beyond the control of AdventureORX, including strikes, labor disputes, government restrictions or regulations, limitations on travel or gathering of groups, limitations or restrictions on hotels, travel or transportation facilities, commodities or supplies, or other calamities or casualties, acts of war, terrorism, disaster, civil disorder, epidemic, pandemic, or public health emergency, or severe weather experience or other Act of God (individually or collectively, a "Force Majeure"). AdventureORX may, in its sole discretion, resume or reschedule any Experience which is canceled, postponed or terminated due to Force Majeure.
